Primary energy use

About primary energy use

- the energy used to produce the fuel and deliver it to the property

How this affects your energy bills

An average household would need to spend **£1,316 per year on heating, hot water and lighting** in this property. These costs usually make up the majority of your energy bills.

You could **save £144 per year** if you complete the suggested steps for improving this property's energy rating.
